


Active oil and gas activities





Oil and Gas Boom..

Oil and Gas is discovered



Entities are established

Infrastructure is built

Local labour market is protected

Special immigration options evolved



Namibia

- > Short Term (Under 90 Days)
 - Further applications can be filed from Namibia
 - No local contract required
- Work Permit
 - Local contract required
 - Local labour market search required



Nigeria

- Temporary Work Permit (TWP)
 - Rotations
 - Maximum validity of 6 months
- STR Visa and CERPAC (Oil and Gas)
 - Managerial/Supervisors
 - Additional local labour market search + content board approval



Mozambique

- Work Permit (Quota)
 - Quota dependent on company size
- > Short Term Work Authorisation
 - 180 days per year; high fees
- **➢** Government Approved Projects
 - Streamlined process
- Work Permit (Out of Quota)
 - Proof of qualifications and lack of local labour



Ghana

- > Petroleum Commission establishment
 - Policies and Impact
 - Work Permit (Oil and Gas)
 - Compulsory local labour market search + Petroleum
 Commission approval
 - Rotator Permit
 - Not implemented in practice





General Red Flags

- 1. Regulation changes/electoral cycles
- Lack of reliable infrastructure
- 3. Corruption



Oil price takes a dive





Oil and Gas Industry Red Flags

- ➤ Oil price drop
 - General cost cutting shorter assignments;
 cancelled assignments; less expatriates
 - Amalgamation of companies
- > Protection of local labour



Oil and Gas Assignment Red Flags

- Home employment contract
- No university degree
- Linked entity?
- Little access to reliable information
- Specific permit route?





Looking forward...

Prediction	What prediction could mean for us
Alternative energy source exploration	More companies needing immigration assistance
Local labour market protection	Awareness of any quota/skills transfer plans in- country, immediate query to host entity
Seismic exploration	Call for immigration assistance into new locations e.g Gabon; Chad; Madagascar
Natural gas growth	Volume into Mozambique, Angola and Tanzania
Office consolidations	Assistance with updating work permits for correct sponsor company; de-registrations of leaving assignees; corporate registration/quota checks
